(NASDAQ: UCBI) ("United"), reported that its Board of Directors approved a quarterly cash dividend of \$0.23 per share on the Company's common stock. The dividend is payable July 5, 2023 to shareholders of record as of June 15, 2023.

The Board of Directors also approved a quarterly cash dividend of \$429.6875 per share (equivalent to \$0.4296875 per depositary share or 1/1000th interest per share) on the Company's 6.875% Non-Cumulative Perpetual Preferred Stock, Series I (NASDAQ: UCBI). The dividend is payable June 15, 2023 to shareholders of record on May 31, 2023.
